Scope of Work:

- 1. To appear and represent the Bank before Civil Courts, DRT, DRAT, Consumer Forum, Labour Courts, and other judicial or quasi-judicial authorities.
- 2. To handle recovery suits, arbitration proceedings, and cases under the SARFAESI Act.
- 3. To issue legal notices, draft petitions, replies, and written statements on behalf of the Bank.
- 4. To vet and certify legal documents, title deeds, mortgage papers, and loan documentation.
- 5. To provide legal opinions and guidance on banking and co-operative law matters.
- 6. To assist the Bank in framing and reviewing legal policies and documentation formats as required.
- 7. Any other legal issues

- 1. The applicant must be a practicing Advocate enrolled with the Bar Council and holding a valid registration.
- 2. Must possess a minimum of 15 years of experience in handling banking cases, with special reference to the cooperative banks.
